### 2023 YEAR IN REVIEW: A MESSAGE FROM OUR CEO


#### -A YEAR OF EMPOWERMENT

In 2001, civil rights activists saw the crucial need for a unique organization dedicated to preserving and fighting for the civil liberties of Muslims in America. In 2023, MLFA marked 22 years since its founding in the aftermath of a tragic event that profoundly impacted the Muslim community globally. This tragedy's echoes are still felt today, both domestically and worldwide. Back then, they understood what is now evident to us all—the Muslim community requires a legal force to challenge laws intentionally designed to harm us.

In 22 impactful years, our generous supporters (you) have helped us raise more than \$60 million, enough to push back those who work to silence us, oppress us, and treat us as probationary citizens. Labeled, targeted, surveilled, and intimidated, we've persisted with your unwavering support. Year after year, armed with top-tier constitutional and national security federal litigators, we fearlessly confront any accusation in federal courtrooms, demanding proof. We boldly say NO to injustice against Muslims and Muslim organizations, rejecting the systemic anti-Islamic bigotry embedded in our laws. We resist the anti-Muslim bias that unfairly labels our children, siblings, or associates under "guilt by association," protecting the vulnerable from entrapment. We ensure that our day in court and our right to a fair trial are met. They push and we push back.

In 2018, when I joined MLFA and began my conversations with our donors across the nation, I realized that many in our community felt as though Muslims were now safe in America. That 9/11 was a thing of the past. Many didn't understand the need for organizations like MLFA. As 2023 began, we knew that we needed to UNVEIL the INJUSTICE that continues to plague us, not only in our communities but also and especially in our legal system. This year, uplifting and empowering our community became a very intentional goal that we set as an organization. The guise of national security is vague (on purpose) and the casting of its net is wide. Our legal team wished that we could get to the community before having to see them in court. So, we made it happen.







This past year, MLFA served over 150 clients on federal constitutional or national security legal matters across our Civil, Criminal Defense, and Immigration departments. We received and responded to over 500 legal intakes, launched our Education Pillar allowing us to empower over 41,983 people nationwide, and produced legal resources in response to the War on Gaza. Because of YOU, we were also able to educate over 3,925 leaders and community members through our new MLFA In Your Community program and re-integrated our Nonprofit training department (providing legal health and governance screenings) back into the fold of MLFA. In 2023, we doubled our staff, starting the year with 12 Full-Time Staff and ending the year with 25. We received the GreatNonprofits award five years in a row, platinum seal of transparency, and a 3/4 star rating on Charity Navigator!

Our accomplishments would not be possible without your support. MLFA was built for this moment in time. MLFA is the leading Muslim-centric legal authority on national security and constitutional law in the nation.

We move into 2024 after experiencing the strongest mission-impact year in our organization's history. Operating with excellence, along with your commitment to justice, MLFA will continue to educate, protect, and defend American Muslims and Muslim organizations against systemic oppression and institutionalized Islamophobia across the nation in our communities and federal courtrooms. We are ready to grow (again) and we are confident that with supporters like you at our side, justice for Muslims and minorities will prevail.

Together, we are the legal force for Muslims and minorities in America.



## Educate | Protect | Defend

### **EDUCATE:**

- Established MLFA's Training & Education Department.
- Named Catherine McDonald as Training & Development Manager.
- Educated over 41,983 people in 2023.
- Led 84 Community Engagement events across 17 states, empowering 33,600 members of our community.
- Launched "MLFA In Your Community" and trained over 3,925 leaders and community members.
- Hosted Virtual Town Halls and trained over 858 leaders & community members on how to address the Gaza Impact.
- Hosted Continuing Legal Education (CLE) Training for the Legal Community training over 100 lawyers in Dallas.
- Sponsored University of Michigan Law School student Zainab Bhindarwala, through the Tarek Al Kadri Social Justice Leadership Scholarship, marking this our 3rd year of scholarships through Islamic Scholarship Fund.

### **PROTECT:**

- Transitioned partnership with Indiana University's Lilly Family School of Philanthropy in-house from the Ihsan Standard Nonprofit project to become the Nonprofit Department of our Legal Division.
- Re-established MLFA's Nonprofit Department, to focus on conducting legal screenings assessing governance, risk, and compliance against federal nonprofit guidelines.
- Provided training and research for established Muslim nonprofit organizations nationally.
- Hired Sana Saleem as Program Manager and Staff Attorney for our Nonprofit Department, along with 2 consulting attorneys.
- Initiated the design and research phase for crafting a curriculum tailored to Muslim nonprofit organizations and individuals, aiming to tackle crucial areas that uniquely affect our communities. Topics covered include nonprofit governance, fundraising compliance, employment law, international nonprofits, and more.
- Consulted with over a dozen nonprofit organizations going through nonprofit governance, compliance, and other legal matters.

### **DEFEND:**

- Our Legal Division received over 500 assistance inquiries from the community in 2023.
- Our team dealt with over 200 active legal matters.
- We served dozens of clients in cases that span several months to several years long!
- We won a historic outcome in the case of a young Muslim man in his 20s wherein the government dropped four counts of material support of terrorism, and brought a sentence of 80 years in prison down to 8 years or less for this young man!

### **CIVIL LITIGATION**

MLFA's Critical Role in Defending & Protecting American Muslims for Palestine (AMP).

MLFA stands for AMP in court, so that AMP can stand for Palestine in the United States!

Since 2017, MLFA's legal division has been protecting and defending AMP, and continues to represent AMP free of cost, as always, in its fights, on many fronts, in courtrooms across America.

In May 2017, right-wing forces attempted to hold AMP accountable for a decades-old judgment against defunct Palestinian entities. Despite being created in 2006 and having no involvement in the earlier lawsuit. AMP faced legal challenges, was accused of operating as the "alter ego" of those entities to avoid the prior judgment. It defended itself on multiple legal fronts for a debt it did not incur, facing liability without a trial for events predating its existence.

### That's when MLFA attorneys got involved.

Our opponents thought they'd have an easy win-they won several key steps in their legal history, by default, because the other entities could no longer pay to defend themselves and did not have legal counsel.

Many forces hoped to bankrupt AMP, to shut it down without the burden of substantiating any allegations. Our Civil Litigation attorneys quickly got involved in the legal proceedings against AMP within a month of their initiation. Uninterrupted and unwavering, our legal team entire seven-year duration of the litigation.

Our donors made it possible for our attorneys to work tirelessly on behalf of AMP free of cost so that it did not suffer the same fate as other defunct Muslim nonprofit organizations.

Imagine navigating this genocide without a trusted resource like AMP standing with our community. Instead, our Civil Litigation team, led by Civil Litigation Department Head Christina A. Jump, and has been by AMP's side from the start seven years ago, turned the

### CRIMINAL LITIGATION

FBI Targeting: MLFA Sets Legal Precedent

MLFA Wins First Dismissal of Material Support Charges In An Undercover Operation Targeting An American Muslim Since 9/11!

We're witnessing an alarming surge in FBI undercover operations targeting our Muslim community. With billions of dollars pouring into the national security budget, our communities are facing entrapment, extensive surveillance, undercover schemes, and an alarming rise in anti-Muslim bigotry and media bias.

### The Unsettling Connection:

Entrapment: Teens, reverts, and those facing mental health challenges are being deliberately targeted by the FBI.

Media Bias: Reporting glorifies the FBI for stopping a terrorist attack and ignores the FBI's tactics of targeting a vulnerable individual, and then creating a crime.

Increased Surveillance: FBI operations are compromising our privacy with budgets in the billions.

### The Jason Fong Case ANOTHER FIRST:

In a groundbreaking moment, MLFA achieved an unprecedented victory. After a mistrial, the U.S. Attorney's Office dismissed all material support of terrorism charges against Jason Fong, a Chinese-American revert. This marked the first dismissal of such charges in an undercover operation targeting an American Muslim since 9/11—a precedent our Criminal Defense Litigation Department was proud to set.

We take immense pride in celebrating the accomplishments of MLFA's Criminal Defense Litigation Department, headed by Charles Swift. Charles began his fight for civil rights more than 20 years ago with a pivotal victory in the U.S. Supreme Court case Hamdan v. Rumsfeld on behalf of Salim Ahmed Hamdan.

In Fong, our team partnered with local counsel to expose the abusive tactics, questionable backgrounds of the undercovers, and the overcharging that too often underlies FBI undercover operations against American Muslims.

By putting his statements in context and compelling the government to disclose these tactics, which, in Fong's case, included the targeting of a Muslim child in conjunction with Fong, we won a victory not just for Jason but for our community.

## MLFA is the only NATIONAL criminal legal defense fund for Muslims!

A genocide is unfolding in realtime, and speaking out against the horrors taking place in Palestine is a constitutional right. But, we also know that when our most vulnerable speak out, they become targets of the FBI and subjected to intense questioning, surveillance, and possible entrapment. The urgency to protect those who boldly advocate for a free Palestine has reached unprecedented heights.



### IMMIGRATION LITIGATION

MLFA v. USCIS, FBI, and US Attorneys' Offices

MLFA's client applied for naturalization over 20 years ago. This same application is still pending at USCIS (formerly INS). The Service has interviewed this client four times, and the FBI has conducted multiple interviews to identify national security issues.

In 2022, MLFA attorneys entered notices of appearance for this client's naturalization application and green card renewal after reviewing his FOIA documents, which revealed USCIS was processing his applications under CARRP. The government's concerns revolve around "guilt by association" and purported national security concerns related to cultural and social organizations in which our client was involved.

In response to MLFA's administrative advocacy, USCIS "reopened" this client's N-400 application, which it administratively closed for 12 years without notice.

The Service then conducted a fourth naturalization interview in September 2023, where MLFA's attorneys provided copious updates to his application and legal arguments supporting a favorable resolution. Although the USCIS officer strongly indicated the Service would issue a quick decision approving the naturalization application, it remains pending as of November 2023. MLFA is now preparing for federal court litigation under 8 USC § 1447(b) based on USCIS's continued delay on this application.

This client's long-pending citizenship application remains pending, but USCIS approved the renewal of this client's permanent resident card in 2022. MLFA was also able to resolve this client's green card renewal application in two months after it had been pending at USCIS for almost two years.

The only impediment to USCIS's approval of MLFA's client Adjustment of Status application before her travel abroad in 2020 seemed to be the FBI's desire to speak to her spouse. The Immigration Litigation Department believes this is a case where DHS is targeting the client's immigration application to pressure her spouse to speak to the FBI, possibly to become a confidential informant. This is an all-too-frequent occurrence of discrimination against vulnerable immigrants targeted by the U.S. government based on race, religion, or national origin.

There are no issues related to criminal conduct, immigration violations, or any other reasons why her application should not have been approved after the first USCIS interview in March 2018.

MLFA's Immigration Litigation Department looks forward to assisting our client with her green card application now that she has returned to the U.S.



### NONPROFIT GOVERNANCE DEPARTMENT

MLFA's Pro Bono Legal Screening Strengthens 75-Member Islamic Schools League of America

The Islamic Schools League of America (ISLA) works in partnership with educators, organizations, and universities to foster the development, growth, and quality of Islamic education primarily by establishing networks, providing resources, disseminating knowledge, nurturing leadership, and carrying out critical and foundational research on Islamic education and full-time schools.

The Islamic Schools League of America envisions and works towards the day when Islamic schools will be the preferred centers for learning and leadership that nurture and encourage America's youth to develop their innate creativity and inquisitive nature in the pursuance of academic excellence while anchoring their hearts and souls in a moral framework of a God-centered life.

There are currently 75 member Islamic Schools, and approximately 300 full-time Islamic schools located in the United States that are part of ISLA's directory. The organization's goal is to make it easier for Islamic schools to access vital information that would enhance a school's instruction and the professional development of their faculty. With this goal in mind, ISLA approached the [MLFA's Nonprofit Department] early 2022 to help with its governance. During its legal screening, we successfully identified key best practices for the organization to improve upon or implement, with the focus for the leadership training in the areas of controls and

The organization was immensely grateful and very receptive to making the changes suggested by [MLFA's Nonprofit Department] so much so that they have recently reached back out to MLFA for a follow up legal screening in light of the changes ISLA implemented after their initial legal screening.




### AMERICAN MUSLIM LEGAL ECOSYSTEM (AMLE)

MLFA in partnership with CAIR-Chicago launches the American Muslim Legal Ecosystem (AMLE) project - Grant funded by The Community Collaboration Initiative (CCI) through Tides Foundation.

When Muslim Americans need legal support and do not know where to go or who to turn to, many get left behind. Legal support is much like health support: people's lives are at risk if their legal troubles are not handled with care. Since the September 11th attacks, Muslim Americans and Muslim organizations have felt "threatened" and under "attack" through surveillance, terrorist watchlists, national registries, Muslim Travel Bans, and more measures cast from all levels of government. Despite more visibility and bridge building in our broader communities, we have been working in silos due to fear, perceived scarcity, and the need to survive.

Through this grant and partnership with CAIR-Chicago, we are collaborating on a legal resource database for American Muslims and a portal that will serve as an immediate support for Muslims seeking legal assistance, allowing us to close the gap in access and resources for our community. We've hired Haazim Patel as Research Associate & Project Manager in 2023 to lead the project in conjunction with our organizations' leadership and we are working to start rolling it out in 2024!





### UNVEILING INJUSTICE: A GALA EVENT

Nearly 700 of you joined us in our groundbreaking series of banquets hosted across the nation—from the heart of our headquarters in Dallas to the vibrant activism scene in New York and the brilliant innovation hub of California—MLFA orchestrated a transformative experience dedicated to dismantling the chains of injustice. Unveiling the stark realities of systemic bias and paving the path towards equality, these banquets weren't just typical events: they were catalysts for real change.

It was our honor to host a lineup of distinguished speakers who brought unparalleled insight and inspiration to the stage. Notable figures included Shaun King, renowned for his impactful activism; Dr. Yusef Salaam, a powerful advocate for justice and a member of the Exonerated Five; Dr. Hatem Bazian, a leading scholar in Islamic studies; Dr. Debbie Almontaser, a trailblazing educator and community leader; and Prof. Jonathon Brown, an esteemed academic. Imam Mohammad Qatanani graced our stage in New York bringing tears to the audience's eyes with his motivational address. In Dallas, Shaykh Abderraoof Alkhawaldeh sparked an energy impossible to contain, forcing us all to confront injustice!

We were privileged to have Judge Zahid Quraishi, the first Muslim Article III federal judge in U.S. history, as a distinguished speaker at our New York event. His presence added a significant perspective to our discussions, emphasizing the crucial role of diversity and representation within the legal system.

Each meticulously curated night was a testament to our commitment to ignite passion, empower voices, and shatter the barriers hindering progress. The impact was undeniable—a collective unleashing of power to challenge bigotry, change oppressive systems, and usher in a new era of justice.

Our commitment to unveiling the truth in a time where exposing injustice is paramount, our events stood as powerful symbols of our collective strength.

### UNVEILING INJUSTICE TRIBUTE TO TAREK AL-KADRI

We gathered in the heart of New York and Dallas for our Unveiling Injustice events with a shared purpose and to pay tribute to a remarkable man, Tarek Al-Kadri. Tarek was more than a leader; he was a legend, leaving an undeniable mark on everyone he encountered. The occasion marked our first large-scale, in-person event since Tarek's passing in 2021. Tarek's ability to face adversity with a radiant smile, his leadership, and the profound impact he made on many lives propels us forward.

Our decision to hold our events in New York and Dallas was deliberately in his honor. InshaAllah, our events ensured that Tarek's legacy continues to thrive, not just within MLFA but within the countless lives he touched.


#### -THE TAREK AL-KADRI SCHOLARSHIP

## GAZA: Our Response!

### AN EDUCATIONAL SERIES BY MLFA

In the wake of the devastating events of October 7th, MLFA sprang into action, driven by a steadfast commitment to support and protect our community amidst the ongoing genocide in Palestine. Recognizing the urgent need for resources and guidance, we swiftly launched a dedicated website offering Gaza Impact educational resources. Within days, we organized a virtual town hall event led by our legal department heads. This forum, attended by over 400 community members, provided vital insights and addressed pressing concerns regarding sending aid abroad, free speech limitations, travel regulations, and FBI monitoring.

In addition to these immediate measures, we increased our efforts with a comprehensive array of educational resources directly related to the impact of the genocide. From informative YouTube videos covering key legal topics to in-depth articles on preventative actions and compliance measures, we equipped nonprofits with essential knowledge and tools to navigate challenging times.



Our nonprofit training session, "Gaza Impact: Is Your Nonprofit Safe?", offered invaluable guidance to Muslim nonprofits on compliance, empowering organizations to safeguard their operations and uphold their missions in the face of adversity. Through multiple in-person events held across the country, we fostered meaningful discussions and solidarity within our community, amplifying our collective voice in support of justice and humanitarian efforts.



### Gaza-Related Cases / Intakes

Within weeks of October 7th dozens of cases flooded our legal intakes team.

We saw a 120% increase in case intakes received compared to similar time periods last year, and 119% increase in intakes our team responded to!

### CIVIL LITIGATION

MLFA has extended its representation of AMP beyond the existing Boim lawsuit to cover:

- O1 The Virginia Civil Investigation request, for which we submitted our initial response on Dec 11; and Working with the DOJ's Civil Rights unit to investigate Hyatt's cancellation of its contract with AMP.
- We've accepted representation in a matter spearheaded by Harvard Law students to complain about multiple incidents of Islamophobia on the Harvard campus, which begins with complaints to the Dept of Education under Title VI.

### **CRIMINAL LITIGATION**

### Requests Received:


Support provided to individuals returning from Gaza in their dealings with the FBI. Assistance requests with GoFundMe donation campaigns.

MLFA has formed attorney/client relationships with individuals related to issues cited above. We have signed limited representation agreements (full representation not required as none have pending cases yet.)

Several significant intakes within our Immigration Department have emerged in direct correlation with the events of October 7th. Among them, one long-term client, whose USCIS application with ties to Palestine appeared to MLFA imminently for a positive resolution after an in-person interview in September 2023. This case is unfortunately indefinitely stalled, but our legal team remains steadfast in their representation. Additionally, an older intake, initially unrelated to Palestine, has become entangled with the aftermath of October 7th and its subsequent events.
